

## Why are these changes being made?

The Council has looked carefully at all the survey returns. As far as possible the proposed changes are consistent with the wishes of most respondents for their streets. A full street-by-street breakdown of the survey results, with area summaries, will be available for scrutiny at the forthcoming exhibition and on the Council's website.

## Will there be any new costs?

The cost of permits and visitor vouchers are reviewed periodically but there are no increases planned with these proposals. Visitor using new pay-and-display facilities will pay the existing EG on-street tariff during the controlled period, which is £1.00 per hour (20 for 12 minutes) - maximum stay 2 hours.

## How can I influence the proposals?

You can influence the proposals by completing the enclosed questionnaire and returning it using the prepaid postage envelope provided. Alternatively you may respond on-line at the Council's website or by email to the address below.

If you would like more information, you are advised to attend the public exhibition to discuss your concerns with officers before commenting on the proposals, or contact us on one of the phone numbers below.

## What happens next?

Once the consultation period has finished the Council will consider any requested changes to the proposals and decide how these should be taken forward. We will then write to you again with details of the final proposals.

Subject to the outcome of this consultation and statutory procedures, we will aim to implement the proposals during October 2017. The new controls would take effect as soon as possible thereafter.

## Thank you for responding to the survey

Towards the end of last year, we asked you to complete a questionnaire on the possibility of introducing more onerous parking controls into your area.

We would like to thank all those who responded to this survey. The responses have helped us to design proposals which are now being brought forward for public consultation.

The main aim of the proposals is to reduce long-stay parking by non-permit holders and free-up space for the essential needs of local residents and traders.

## What are the proposals?

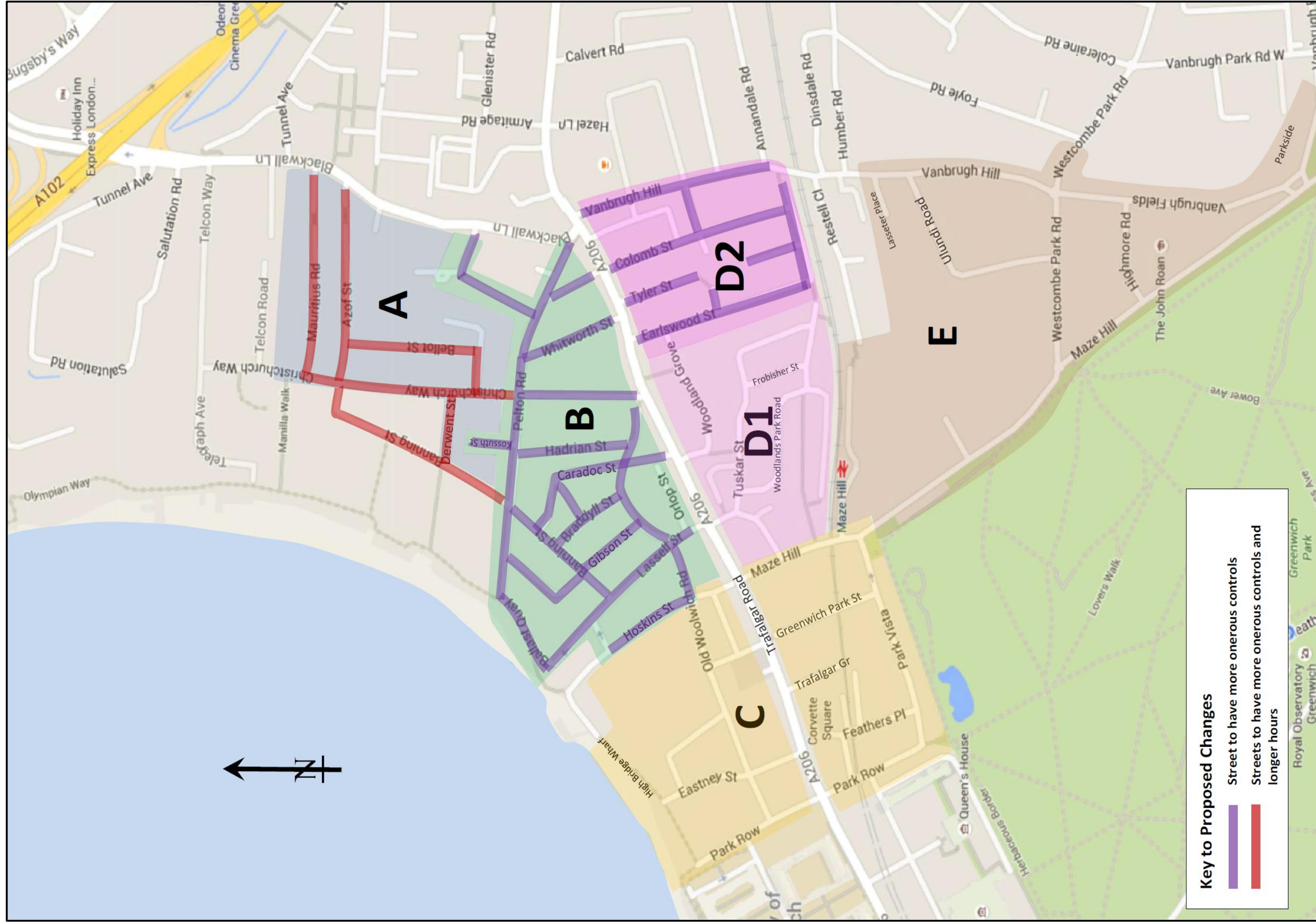
An overview of the proposed changes is shown overleaf. These broadly comprise:

- **Area A:** replace all free and/or limited waiting bays with a combination of "permit holders only" and shared "permit / pay-and-display" places, with operational hours extended to Monday – Sunday, 9am - 8pm.
- **Areas B and D2:** replace all free and/or limited waiting bays with a combination of "permit holders only" and shared "permit / pay-and-display" places, with the existing operational hours Monday – Sunday, 9am – 6.30pm. Some additional parking is proposed on Vanbrugh Hill.
- **Areas C, D1 and E:** no proposed changes.

Draft detailed plans for Areas A, B and D2 are included with this package. Larger scale version of these will be available to view at the forthcoming exhibition. The plans can also be viewed on the Council's website (click on "take part in consultations...").
